BY BENJAMIN RASMUSSEN

The Good Citizen explores how society in the United States came to be what it is today. Who was freely invited into this space and who wasn't? In what ways are the ripples of our past seen in our present? How can we engage more honestly with our history?

Over a period of eight years, photographer Benjamin Rasmussen travelled to 43 states and photographed over 500 people as he investigated the impact of the country's complex history on contemporary society.

In the book version of *The Good Citizen**, Rasmussen's photographs are combined with essays by Frank H. Wu. Collectively they seek to provoke thought and conversation around the complicated nature of US identity. Crew 174 on an EVA in Lith Canyon. Mars Desert Research Station, Hanksville, Utah

- 3 The view from where Arapahoe and Cheyenne women and children watched themilitia riding towards them. *Kiowa County, Colorado*

Chivington attacked the village [of Sand Creek] early in [the] morning. I had not got out of bed when I heard soldiers were coming. I looked towards Black Kettle's lodge and he had [an American] flag on [a] pole in front of his lodge. Just then the soldiers opened fire from all sides of the Village. We past (sic) good many men women and children. Killed. Good many of these were scalped. I suppose you have read how some women were cut up and the men also. Chivington's men did not leave us until 5 in evening. Chivington's men took 2 girls and a boy with them. The government got the boy back from [a circus] show. This boy, of course now man, is living. Name Tom White Shirt.

The four occupants of the car never reached their destination on that fateful afternoon.

They may have recognized one or more members of the mob.

Cabeza Prieta National Wildlife Refuge, Arizona

If we use six liters as a minimum adequate intake for adults walking several miles a day during hot summer months, a person would need to consume approximately 1.6 gallons a day to prevent dehydration. If someone walks for three days, which is the approximate time it takes to get from the border to one of the common rendezvous locations in southern Arizona (e.g., Three Points), they minimally need to carry 4.8 gallons. A gallon of water weighs 8.35 pounds, which means that someone carrying four gallons starts their trip with 33.4 lbs of liquid. This weight would be augmented by food, extra clothes, and other supplies. Based on my observations and interviews, the maximum amount of water an adult can carry is four gallons, with many opting to bring between one and two.
